In addition to making the results of this survey available to the public; I am forwarding copies to each Division Commander to analyze and make necessary adjustments to their operations and enforcement strategies.







Q2 Crime Rate: Do you feel that the overall rate of crime in St. Mary's County has increased in recent years?





Q3 Community safety: Do you feel that the St. Mary's County Sheriff's Office is effectively maintaining community safety?





Q4 Traffic enforcement: Does the Sheriff's Office conduct adequate traffic enforcement in St. Mary's County?





Q5 Traffic enforcement: Does the Sheriff's Office adequately enforce traffic regulations in residential neighborhoods?





Q6 Traffic enforcement: Does the Sheriff's Office adequately enforce traffic regulations around public and private schools?





Q7 Traffic enforcement: Are you in favor of speed enforcement cameras in and around school zones in St. Mary's County?





Q8 Professionalism: Do you feel that the St. Mary's County Sheriff's Office is a professional and effective agency?





Q9 Resources: What tools do you think that the Sheriff's Office needs more of to do its work effectively in enforcing laws?





Q10 School resources: Do you support the Sheriff's Office's School Resource Officer program?






Q12 School resources: Do you support DARE (Drug Abuse Resistance Education) curriculum being taught in public schools by SROs?


Q13 Citizen contact: Do you feel that the Sheriff's Office treats citizens equitably and fairly?







Q14 Citizen contact: Have you personally interacted with a sheriff's deputy in the past year?





Q15 Citizen contact: Was your experience with the deputy positive?





Q16 Citizen contact: Did the deputy respond to your call for service in a timely and professional manner?









Q21 What is your gender identity?


