### ARRESTS

On February 14, 2014, Deputy Cole responded to the San Souci plaza in California for an assault in progress. The investigation revealed suspect **Ronnie nmn Glenn, 50, of Saint Leonard, Maryland**, grabbed the victim by the throat and then drug the victim from the passenger seat of the vehicle during an argument. Glenn was placed under arrest and transported to the St. Mary's County Detention Center. He was charged with 2<sup>nd</sup> Degree Assault.

On February 14, 2014, Deputy Lance responded to Walmart in California for a theft. Loss Prevention personnel observed 2 females place merchandise into a shopping cart and attempt to leave without paying. The suspects were stopped and returned to the store. The suspects were identified as **Emma Jean Butler, 53, of Mechanicsville** and **Shameka James Butler, 34, of Indian Head**. The value of the stolen items was over \$190. Both were charged with Theft Under \$1,000 by criminal citation.

On February 16, 2014, Deputy Lance assisted Sergeant Young with a vehicle stop. While doing so, Deputy Lance obtained a social security card from suspect **Genaro Hernandez Reyez, 49, of Lexington Park**. Deputy Lance found many of the security features on the card were inconsistent with those cards issued in 2009. After additional investigation, the card was determined to be a fictitious and fraudulent government document. Reyez was placed under arrest and transported to the St. Mary's County Detention Center. He was charged with Possession/Use of False Government Identification Document.

On February 16, 2014, Corporal Connelly responded to ABC Liquors in California for a disturbance. Corporal Connelly made contact with several subjects including suspect **Ryan Michael Dale, 21, of Lexington Park**. Dale was yelling and was asked by deputies to lower his voice several times. Another patron of the establishment began to leave at which time Dale

walked toward the patron in an aggressive manner. Deputies stopped Dale who then pulled away. Dale was placed under arrest at that point. Richard Michael Woodburn, 33, of California, was also arrested after he refused all orders made by Deputy Potter to stop yelling, which was inciting other individuals to fight. Both were transported to the St. Mary's County Detention Center and charged with Disorderly Conduct.

On February 17, 2014, Deputy Knott responded to the area of Charles Way in Lexington Park for an assault. The victim alleged suspect **John Rhudorf Frances Epp III, 28, of Lexington Park**, was seated in his vehicle at which time the victim approached the vehicle to have a conversation. The suspect suddenly put his vehicle in reverse then turned the steering wheel and accelerated striking the victim. The vehicle knocked the victim to the ground. The victim was transported to St. Mary's hospital with non-life threatening injuries. Epp was located at his residence and placed under arrest. He was transported to the St. Mary's County Detention Center and charged with 1<sup>st</sup> Degree Assault.

On February 17, 2014, Corporal O'Connor observed a vehicle sitting on the shoulder of Three Notch Road in California. The driver, **Jesse Cole Dubac, 20, of Leonardtown**, was outside of his vehicle and advised he had run out of gas. Corporal O'Connor observed a beer in the center console. A further search of the vehicle revealed a glass smoking device with suspected marijuana residue. Additional controlled dangerous substance paraphernalia was located throughout the vehicle. Dubac was placed under arrest and transported to the St. Mary's County Detention Center. He was charged with Possession Controlled Dangerous Substance – Marijuana, and 2 counts of Paraphernalia. Dubac was also arrested for Possession of a Controlled Dangerous Substance on January 30, 2014 by Captain D. Alioto.

On February, 18, 2014, Deputy Bowen responded to a residence on St. Clair Road in California for a disturbance. Suspect **Ronald Paul Colvin, 37, of California**, was intoxicated and threw full beer cans at the victim's 2003 Honda causing damage. The estimated damage was over \$1,500. Colvin continued to yell profanity and threats toward the victim. Colvin was placed under arrest and transported to the St. Mary's County Detention Center. He was charged with Property Destruction Over \$1,000 and Disorderly Conduct.

On February 18, 2014, Deputy Bankhead responded to a residence on Military Drive in Great Mills after the Emergency Communications Center received a 9 1 1 hang up call. The victim alleged suspect **Sandra Jeanette Thomas, 29, of Great Mills**, scratched the victim's back during an argument. Deputy Bankhead observed fresh evidence of injury on the victim. Thomas was placed under arrest and transported to the St. Mary's County Detention Center. She was charged with 2<sup>nd</sup> Degree Assault.
